New Business:

Stonewall Pride Parade: No budget has been submitted. The spot in the parade has been paid for. Steven will reach out to the monarchs to get a finalized budget or plans, we will have to pull out the float and just do a walking group. Looking to possibly make a political statement of dressing in orange jumpsuits with signs saying drag is not a crime. Looking to get 10-15 members in drag and then the statement posters. Ultimately need the monarchs to make a decision.

Parade instructions discussion held with Marc. Drag elements are vague. The officials will make a decision about what we are wearing. We do need to register if going to be on the float/parade & at the festival. Cost is \$11/person.

Bill Byrd suggesting talking to the monarchs about just using a convertible and having a group walking. BOD vote taken all agreed with presenting convertible idea to monarchs.

IRS determination letter. Provides that they recognize us ass a 501C charity. A copy can be provided if needed. We also have a non-tax letter to pay for court stuff (by check or credit card).

Budget must be provided to determine how much we can spend and how much we anticipate making from the event. All budgets must be BOD approved. After event you have 30 days to

present expenses. Must have a receipt for reimbursement of all expenses. Preliminary budget must be in at least one month in advance of event.
